WGC Cautions Against Gold Import Duty Hike in Budget 2025



The World Gold Council (WGC) has raised concerns over the potential impact of an increase in gold import duties in the upcoming Union Budget for 2025. The government's decision to lower the import duty on gold in July 2024 had a significantly positive effect on the industry. It led to a reduction in informal gold imports, stabilized official channels, and fostered a more transparent and organized market. The WGC highlighted that raising duties now could lead to a surge in smuggling, drive up domestic gold prices, and negatively impact the sector's growth.

Sachin Jain, Regional CEO of WGC India, emphasized the importance of maintaining the current customs duty to ensure continued stability in the market. He pointed out that any increase in import duties could reverse the progress made over the last year, especially as the gold industry contributes approximately 1.3% to India's GDP and provides employment to 20-30 lakh people. Jain called on the government, financial institutions, and industry players to work together to preserve the positive momentum in the market, fostering an environment where the gold sector can continue to thrive.

The government's budget announcement on February 1 will be closely watched, particularly as India grapples with weak GDP growth and a slowdown in consumption. With expectations for progressive, industry-friendly measures, the WGC hopes that the government will maintain its stance on reducing gold taxes and focus on measures that support economic growth while benefiting all stakeholders in the gold industry.

India GJ exports down by 10.29% , imports down by 27.23% in December 2024



The overall gross exports of Gems & Jewellery in December 2024 stood at USD 1967.98 million (Rs. 16719.460 crores), showing a decline of 10.29% compared to USD 2193.82 million (Rs. 18269.7 crores) for the same period last year. This is due to the economic uncertainty looming in the market due to which buyers are leaning more towards the yellow metal as safe haven for investments rather than splurging on lifestyle.

Cut & Polished diamonds exports declined by 10.36%; imports declined by 64.1% in December 2024* Rough diamond imports declined by 22.1%* Polished Lab Grown Diamonds exports decreased by 5.48% Gold Jewellery export declined by 3.56%* Coloured Gemstone exports declined by 11.5%

The overall imports of Gems & Jewellery for December 2024 stood at USD 1526.95 million (Rs. 12992.3 crores) showing a decline of 27.23% as compared to 2098.19 million (Rs. 17468.04 crores) for the same period last year.

US jewellery sector shrinks again in final quarter of 2024



The US jewellery sector shrank again during the final quarter of 2024, with 753 fewer retail, wholesale and manufacturing businesses than there were a year earlier. The Jewelers Board of Trade (JBT), which provides commercial credit information, today (16 January) announced a 3.2 per cent reduction, a marginal improvement on the 3.3 per cent stop during the previous quarter.

There are currently 17,124 jewelry retailers in the US, 3,824 wholesalers and 2,155 manufacturers, according to the JBT statistics, which take account of new businesses as well as ceased operations.

During the fourth quarter, 158 businesses stopped trading. Of those, 23 were sold or merged (mostly retailers). There was only one recorded bankruptcy. A total of 90 new retailers opened during the quarter, together with eight wholesalers and five manufacturers.

Gold rises on Trump announcement of imposing tariffs on Mexico, Canada



Gold rose after US President Donald Trump announced he would likely impose tariffs on Mexico and Canada early next month, even as he held off from immediately hitting China with import levies.

Bullion added to a modest gain on Monday to trade near \$2,725 an ounce - on course for the highest close since early November - as traders weighed the potential implications of US tariffs of as much as 25% against its neighbors. If enacted, the move threatens to spark a trade war.

Gold prices surged to over a two-month high on Tuesday as the U.S. dollar weakened, while the yellow metal was also supported as investors flocked towards it amid uncertainty surrounding Donald Trump's trade policies.
