# RBI issues guidelines for loans against silver



The Reserve Bank of India (RBI) has introduced a formal, standardized framework for loans against silver, which will be fully effective from April 1, 2026. These new guidelines bring silver lending under a unified regulatory umbrella, similar to existing gold loan regulations, to protect borrowers and formalize the market.

#### **Key RBI Guidelines for Loans Against Silver**

The "Reserve Bank of India (Lending Against Gold and Silver Collateral) Directions, 2025" establish the following rules for all regulated entities, including commercial banks and Non-Banking Financial Companies (NBFCs):

- Eligible Collateral: Only silver jewellery, ornaments, and coins with a minimum purity of 925 (sterling silver) are accepted.
- Ineligible Collateral: Loans cannot be offered against primary silver (bullion, bars, or slabs), or financial products like Silver Exchange-Traded Funds (ETFs) or mutual funds.
- Collateral Limits: A borrower can pledge up to a maximum of 10 kilograms of silver ornaments and up to 500 grams of silver coins.
- · Loan-to-Value (LTV) Ratio: The maximum LTV (loan amount as a



- 85% for loans up to Rs.5 lakh.
- 80% for loans between Rs2.5 lakh and ₹5 lakh.
- 75% for loans above Rs.5 lakh.
- Valuation: Silver collateral is valued based on its intrinsic value and actual purity. The reference price will be the lower of (a) the average closing price over the preceding 30 days or (b) the closing price of the preceding day, as published by the India Bullion and Jewellers Association Ltd. (IBJA) or a SEBI-regulated commodity exchange.
- Loan Purpose: The guidelines cover loans for consumption and income generation purposes. Lenders are generally prohibited from extending loans for the speculative purchase of silver.
- Borrower Protection: Lenders must follow standardized procedures for purity checks, provide clear loan terms in the borrower's language, and securely store the collateral. Penalties are in place for delayed release of collateral after full repayment (₹5,000 per day after seven working days).
- No Re-pledging: Lenders are prohibited from re-pledging the silver collateral to other entities.

# China issues new rules for export management of silver



China has issued new rules for the export management of silver, which include a quota system for qualified companies for 2026-2027. This follows a period where quota management for silver exports had been suspended.

The new rules, announced by the Chinese Ministry of Commerce (MOFCOM) on October 30, 2025, aim to "step up the protection of resources and the environment, and enhance the export management" of rare metals including silver, tungsten, and antimony.

Quota System: Export quotas have been reintroduced for silver and certain other rare metals.

Eligibility: The rules specify requirements for domestic manufacturers and traders applying for export qualifications, including criteria related to credit loan quotas and export levels from 2022-2024.

Goal: The measure is intended to ensure only qualified and responsible companies are granted export rights and to strengthen state control over strategic resources.



## Silver surges more than 5% to \$54 as "critical mineral" status reinforces safe-haven appeal



Silver prices climbed more than 5% today, breaking above \$54 per ounce and approaching the all-time high established last month, as investors increasingly turned to precious metals for portfolio protection against mounting global economic concerns. The rally extends silver's weekly gains to approximately 12%, marking one of the white metal's strongest performances in recent months.

Silver's dual role as both a monetary safe haven and an indispensable industrial metal makes this critical mineral designation particularly significant. The USDA's critical minerals classification places silver alongside resources deemed essential to U.S. defense, technology infrastructure, and industrial competitiveness. This designation typically triggers enhanced federal support for domestic production, supply chain security measures, and strategic stockpiling considerations.

Analysts note that silver's supply dynamics differ fundamentally from gold, with approximately 50% of annual production derived as a byproduct of mining other metals. This creates structural supply constraints even as industrial demand accelerates alongside the

global energy transition.

The precious metals complex has attracted significant capital inflows as investors hedge against geopolitical tensions, currency volatility, and inflation concerns. Silver, often called "the poor man's gold," historically demonstrates higher volatility than its yellow counterpart, offering leveraged exposure to safe-haven demand trends.

With prices now within striking distance of recent all-time highs, technical analysts are monitoring key resistance levels while noting that silver's fundamental backdrop-combining monetary demand, industrial necessity, and supply constraints-remains exceptionally robust.

# Precious metals remain elevated on hopes that US data will boost FED rate cut bets AUGMONT BULLION REPORT



- The dollar's decline and the uncertainty surrounding the backlog of official data following the US government's 43-day reopening have helped gold prices rise 4.8% so far this week.
- Some of these releases might be lost completely, but others might show up soon, which would raise concerns about the nation's economic future.
- The U.S. government has opened, though, and as a result of all these concerns about inflation and the slowdown, there was some decline in silver prices as expectations changed to suggest that the Fed might not be ready to cut rates aggressively.
- Markets have lowered their estimates for a December Fed rate cut, giving a 25 basis point cut a 50% chance, down from over 95% a month ago. Meanwhile, betting on cuts in 2026 has not altered.

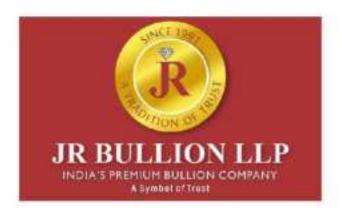
- Gold continues its upside, crossing \$4200, with the next target resistance at \$4300 (~Rs 130,000), with support at \$4100 (~Rs 123,500)
