Over 40 crore gold jewellery items get hallmark in fourth phase, says government

More than 40 crore gold jewellery items have received a unique Hallmarking Unique Identification (HUID) in the fourth phase, enhancing consumer trust and transparency in the market, according to the Ministry of Consumer Affairs, Food and Public Administration.

The Bureau of Indian Standards (BIS) commenced the fourth phase of mandatory hallmarking under the Hallmarking of Gold Jewellery and Gold Artefacts Amendment Order, 2024, starting November 5, 2024.

The fourth phase includes an additional 18 districts where hallmarking centres have been established as part of the Mandatory Hallmarking initiative. With this implementation, the total number of districts now covered under Mandatory Hallmarking has reached 361.

“It is a notable achievement that the proactive measure by the Government of India has triggered over 4 lakh gold items being hallmarked with a unique HUID (Hallmark Unique Identification) number per day,” the ministry said. Since the launch of mandatory hallmarking,

the number of registered jewellers has increased from 34,647 to 1,94,039, a remarkable rise of over five times.

Similarly, the number of Assaying and Hallmarking Centers (AHCs) has grown from 945 to 1,622. BIS earlier implemented the first phase of mandatory hallmarking, which was launched on June 23, 2021. This phase covered 256 districts whereas the second phase commenced from April 4, 2022, where 32 districts were further added.

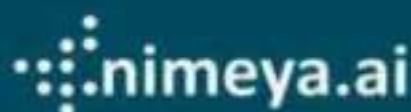

Gold unaffected by US Retail Sales data



The precious metal remains relatively unaffected by the release of US Retail Sales which rose by 0.4% MoM, beating estimates of 0.3% but below the previous month's revised-up 0.8%, according to data from the Bureau of Labor Statistics (BLS).

Gold bounces off technical support aided by the US Dollar, which peaks and rolls over. The precious metal faces headwinds from the outlook for US interest rates and Trumponomics. The stronger US Dollar (USD) continues to put background pressure on Gold since it is mainly priced and traded in the US currency.

The US economy is in “remarkably good” shape, according to Fed Chair Powell, lifting the USD and weighing on Gold. Gold (XAU/USD) trades little changed on Friday, holding steady in the \$2,570s after making a slight recovery from the two-month lows reached on the previous day.

North America inflows go four-for-four

Gold Market Commentary

Under pressure

October in review

Global physically backed gold ETFs¹ extended their inflow streak to six months, adding US\$4.3bn during October (Table 1, p2).² Continued inflows and the record-shattering gold price lifted global assets under management (AUM) a further 5% to another month-end record of US\$286bn. Meanwhile, collective holdings rose 43t to 3,244t. North America once again led global inflows while Europe remained the only region with outflows. Y-t-d global gold ETF demand – led by Asia – has turned positive (+18t) for the first time this year. And so far in 2024, inflows into global gold ETFs have reached US\$4.7bn. Supported by recent inflows and the rocketing gold price, total assets under management (AUM) have soared by 33%. All regions other than Europe have experienced inflows y-t-d.

North America

North American funds have witnessed four consecutive months of inflows, adding US\$2.7bn in October. Continued gold ETF buying may have come as a surprise to many as yields rose and the dollar strengthened, leaving investors re-thinking the future interest rate path amid robust US economic performance. We believe demand for gold was helped by uncertainty surrounding the US Presidential election.³ And the military escalation in the Middle East conflict, along with rumours that North Korea could join the Russian front against Ukraine may have contributed to rising gold ETF demand.⁴ We believe that an element of “FOMO” – fear of missing out – amid the continued surge in the gold price has also helped to boost investor interest.

Europe

European funds continued to see outflows in October, shedding US\$563mn. Notably, outflows were seen across major markets in the region – unlike previous months where the UK bore the brunt of losses. Rebounding yields in the region pushed up the opportunity cost of holding gold and are likely a major driver. Despite the European Central Bank's (ECB) further 25bps rate reduction in the month and a worsening economic picture, yields of local government bonds climbed⁵. This was mainly a result of global investors' re-assessment of central banks' rate paths, particularly the US Fed. Similarly, UK Gilt yields also edged higher during the month, prompting gold ETF outflows.

Meanwhile, weaker local currencies – amid deteriorating economic prospects in Europe and a strengthening dollar – resulted in outflows related to FX-hedging products, adding to the region's losses during October.

Asia

Asian funds attracted US\$2.1bn in October, extending the region's inflow streak to 20 months. China dominated inflows: the record-shattering local gold price and amplified equity market volatility, following a sizable rally in late September fuelled by aggressive stimulus announcements, led to the strongest monthly inflow on record. Meanwhile, Indian gold ETF inflows continued, driven by similar factors: attractive gold price momentum, higher stock market volatility, and the lingering positive benefit of adjustments to the long-term capital gains treatment of gold. 6 Funds elsewhere reported inflows for a fifth successive month. October's US\$68mn inflows were once again mainly driven by Australian and South African funds. In Australia the weakening Aussie dollar enlarged gold's return locally and likely pushed up investor currency hedging needs, contributing to the region's fifth consecutive monthly inflow. Meanwhile, South Africa continues to benefit from cooling inflation, paving the way for a higher probability of rate cuts⁷ and driving the country's six-month inflow streak.

BIS hallmarking now mandatory in 361 districts; 18 new districts added



BIS Mandatory Hallmarking 18 New District Added

On November 5, 2024, the government issued a Gazette notification mandating BIS hallmarking in 361 districts nationwide. This expansion includes 18 newly added districts, building on the previous 343 districts where hallmarking was already mandatory. Among the newly covered regions, Uttar Pradesh and Rajasthan each added four districts.

The Bureau of Indian Standards (BIS) initially launched mandatory hallmarking on June 23, 2021, in 256 districts, marking the first phase. In the second phase on April 4, 2022, the mandate was extended to an additional 32 districts, contributing to over 400,000 gold articles hallmarked daily with unique HUID numbers.

In September 2023, the third phase brought 55 new districts into the hallmarking network, achieving a total of 343 districts. Now, with this latest expansion, 18 more districts across 11 states and union territories are included, furthering the reach of the BIS hallmarking system.

BIS encourages consumers to verify the authenticity and purity of hallmarked gold by checking the HUID number using the "Verify HUID" feature on the BIS Care app, available on the Play Store. The updated district list and further details on hallmarking are accessible on the BIS website

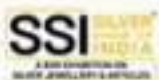

Distinct terminology for natural and LGDs to enhance consumer confidence



At the recently held CIBJO World Jewellery Confederation Congress, the need to clearly differentiate between laboratory-grown and natural diamonds was reiterated. The CIBJO Laboratory-Grown Diamond Committee once again emphasized that all traders dealing in both types of diamonds must unambiguously distinguish between the two, to provide consumers with clear information about their buying choices.

It will be important for both natural and laboratory-grown diamonds to continue to operate as separate market segments without looking to harm or disparage the other, Hunt said. Both products should not make any unsubstantiated sustainability claims.

The following terms can be used to describe LGDs: “laboratory-created diamonds”, and “synthetic diamonds.” However, terms such as “real diamonds” and “eco-friendly diamonds” should not be used, Hunt said, adding that CIBJO welcomed any refinement considerations to the LGD guidelines, and for contributions from LGD trade bodies in the United States, China and elsewhere to re-ignite consumer confidence.
